- 1. The HUD subsidy formulas, which are a major component of the Authority's budget, were delayed due to federal budget negotiations they were not released in time for the Authority to complete and submit its budget before the 60 day deadline.
- 2. Once HUD released its subsidy amounts, the Authority needed additional time to review the HUD budget and make adjustments within its operating budgets before they could be submitted.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Housing Authority of the City of New Brunswick hereby adopts this resolution to submit the late budget in accordance with N.J.A.C. 5:31.
