FISCAL YEAR: FROM 07/1/13 6/30/14 TO WHEREAS, the Annual Budget and Capital Budget for the New Brunswick Housing Authority for the July 1, 2013 ____ and ending ____ June 30, 2014 has been presented fiscal year beginning before the Members of the New Brunswick Housing Authority at its open public meeting of __April 24, 2013_; and WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$___13,777,472 Total Appropriations, including any Accumulated Deficit if any, of \$ 13,774,322 Fund Balance utilized of \$ 0; and WHEREAS, the Capital Budget as introduced reflects Total Capital Appropriations of \$ 446,900 and Total Fund Balance planned to be utilized as funding thereof, of \$ 0 WHEREAS, the schedule of rents, fees and other user charges in effect will produce sufficient revenues, together with all other anticipated revenues to satisfy all obligations to the holders of bonds of the Authority, to meet operating expenses, capital outlays, debt service requirements, and to provide for such reserves, all as may be required by law, regulation or terms of contracts and agreements; and WHEREAS, the Capital Budget/Program, pursuant to N.J.A.C. 5:31-2, does not confer any authorization to raise or expend funds; rather it is a document to be used as part of the said Authority's planning and management objectives. Specific authorization to expend funds for the purposes described in this section of the budget, must be granted elsewhere; by bond resolution, by a project financing agreement, by resolution appropriating funds from the Renewal and Replacement Reserve or other means provided by law. The provision for reserves has decreased from the prior year, due to the sequestration and related anticipation of reduced subsidies for all housing programs

The operating fund balance is expected to increase by approximately \$3,150 as a result of the proposed budget.
