Mr. Hoffman explained that the amendment is for more time. The redevelopment authority was transferred in the 70's by City Council because they felt that the Housing Authority was best positioned to handle redevelopment matters.

James Clarken, representing the redevelopers, noted it is basically the same project as originally proposed and will be vetted by the Planning Board. He stated it is not residential as it is in an industrial zone and not zoned for residential. He further answered that at this time there is no intention to file for a long term tax exemption and the project would be contributing 2% to the affordable housing fund.
