Proposals for Environmental Consulting Services – Fourward Hill Development will be received by the Housing Authority of the City of New Brunswick (“Housing Authority”) at 7 Van Dyke Avenue, New Brunswick, New Jersey 08901, until **March 4, 2026** at **11:00 a.m.**

All proposals shall be submitted in a sealed envelope, labeled “Proposal for Environmental Consulting Services – Fourward Hill Development” and including the respondent’s company name and return address. The envelope must contain a printed copy of the entire proposal and a flash drive containing a PDF copy of the entire proposal. Respondents must ensure that their proposal is received at the address and by the deadline specified above. Proposals received after the deadline for any reason shall not be considered and will be returned to the sender.

All responses submitted are subject to these instructions and to the Instructions to Offerors, Non-Construction form HUD-5369-B. The failure to abide by these instructions in any way, including but not limited to the failure to submit all required documentation, may lead to the proposal being rejected as non-responsive.

The Housing Authority reserves the right to reject any and all proposals and/or to waive any informality in the responses. No proposals may be withdrawn within sixty (60) days after the submission deadline.

In accordance with the criteria included in the RFP, the contract shall be awarded to the respondent who submits the proposal most advantageous to the Housing Authority, cost and other factors considered. The successful respondent will be required to execute the Housing Authority’s contract within seven (7) days of receiving the notice of award.

This RFP is being issued pursuant to a fair and open process in accordance with N.J.S.A. 19:44A-20.4 et seq.

## 1. PURPOSE

The Housing Authority of the City of New Brunswick (hereinafter called “Housing Authority” or “NBHA”) is a public housing agency with administrative offices located at 7 Van Dyke Avenue, New Brunswick, New Jersey 08901. The Housing Authority provides quality, affordable housing to low-income families and seniors through various affordable housing programs, including the Public Housing (285 units) and Section 8 Housing Choice Voucher (968 vouchers) programs.

In accordance with applicable Federal and State of New Jersey requirements, the Housing Authority is currently accepting proposals for **Environmental Consulting Services** on the Fourward Hill development. The successful respondent will work collaboratively with NBHA, its regulators, its development partners, and other consultants to support this development. It is the Housing Authority’s desire to retain the services of a duly qualified company to provide Environmental Consulting services for a term of one (1) year, with an option to extend for up to four subsequent one (1) year terms.

NBHA envisions Fourward Hill as a multi-phase, large scale development that will increase density of residential units, parking, commercial, and community space. It will be developed on the current site of Schwartz Homes, a public housing project consisting of 2 parcels which are bisected by Van Dyke Avenue. The existing project was built in 1985 and sits on approximately 14 total acres of land. NBHA has not yet determined which development funding mechanism(s) will be utilized; mechanisms may include but not be limited to Section 8 Project Based Vouchers (“PBVs”), Rental Assistance Demonstration (“RAD”), Section 18 demolition / disposition, Low Income Housing Tax Credits (“LIHTC”), and other public or private sources.

All services must be provided in accordance with applicable Federal, State of New Jersey, and local statutes, rules, regulations, ordinances, orders, and codes (including the rules, orders, directives, and regulations promulgated by the U.S. Department of Housing and Urban Development (“HUD”).

All proposals shall be reviewed for completeness and shall be analyzed in accordance with the criteria contained herein. Therefore, the Housing Authority urges all interested firms to carefully review the requirements of the RFP, including the attached Instructions to Offerors (HUD-5369-B). Failure to abide by the RFP’s instructions in any way may lead, in the Housing Authority’s sole discretion, to the rejection of the proposal as non-responsive.

## 2. TERMS AND CONDITIONS

Any requests for clarification as to the meaning of any provision of this Request for Proposals shall be submitted in writing no later than **February 20, 2026 at 5:00 p.m.** via email to the Housing Authority’s Executive Director, Daniel Toto, at [dtoto@nbnjha.org](mailto:dtoto@nbnjha.org). If deemed necessary by the Housing Authority, an addendum will be issued to all individuals who were issued a copy of the Request for Proposals. Any prospective respondent obtaining the RFP from the Housing Authority website shall be responsible for ensuring they are aware of any addenda to the RFP by verifying such with the Housing Authority prior to submission. Failure of any proposer to

receive any such addendum shall not relieve them from an obligation under their proposal as submitted.

All proposals shall remain valid for a period of sixty (60) calendar days after the date specified for receipt of proposals. All costs of the proposal process, interviews, and related expenses, are solely the responsibility of the respondent.

The Housing Authority reserves the right to reject any or all proposals, to waive informalities and minor irregularities, and/or modify or cancel this Request for Proposals. Proposals which appear unrealistic in terms of management commitments or are indicative of failure to comprehend the complexity of this RFP and subsequent contract may be rejected.

Respondents are requested and advised to be as complete as possible in their response. The Housing Authority reserves the right to 1) contact any respondent to clarify their proposal; 2) contact any past/current clients of the respondent; 3) solicit information from any available source concerning any aspect of the proposal; and 4) seek and review any other information deemed pertinent to the evaluation process.

### **3. SCOPE OF SERVICES**

The successful respondent shall be required to provide the full range of Environmental Consulting services on the Fourward Hill development. This is a large-scale, multi-phase development potentially involving multiple development partners across phases. NBHA is seeking environmental review and technical support services by a firm qualified to prepare an American Society for Testing and Materials (“ASTM”) compliant Phase I Environmental Site Assessment (“ESA”) and support HUD environmental reviews under 24 C.F.R. Part 50 (“Part 50”) or 24 C.F.R. Part 58 (“Part 58”).

The Scope of Environmental Consulting Services being requested shall include, but not limited to, the following:

#### **(A) Environmental Review Strategy**

1. Review project scope, phasing, and funding sources to assist the NBHA in confirming the appropriate environmental pathway (Part 50 or Part 58) for each phase.
2. Advise on environmental review sequencing for a multi-phase project, including reevaluations where applicable.
3. Coordinate environmental review timing with Rental Assistance Demonstration (“RAD”) Milestones, Section 8 Project-Based Voucher (“PBV”) awards, financing and construction schedules.
4. Align all documentation with the HUD Environmental Review Online System (“HEROS”) workflow and requirements.

#### **(B) Phase I Environmental Site Assessment**

1. Prepare ASTM E1527-21 compliant Phase I ESA, including vapor encroachment screening consistent with ASTM E2600, as appropriate.
2. Conduct site reconnaissance, historical use review, regulatory database review, and interviews.
3. Identify and clearly document Recognized Environmental Conditions (“RECs”), Historical RECs, and Controlled RECs.
4. Prepare Phase I ESA reports suitable for HUD review, N.J. Housing and Mortgage Finance Agency (“NJHMFA”), LIHTC investor and lender due diligence.
5. Update or rely upon Phase I ESAs for subsequent phases, consistent with ASTM shelf-life requirements and HUD guidance.

(C) HEROS and HUD Part 50 or Part 58 Hazard Analysis

1. Prepare concise narratives, exhibits, and technical memoranda suitable for upload into HEROS.
2. Address all applicable HUD environmental laws and authorities including, but not limited to:
  - a. Toxic and hazardous substances and site contamination
  - b. Floodplains and wetlands (24 CFR Part 55)
  - c. Noise (24 CFR Part 51, Subpart B)
  - d. Explosive and flammable hazards (24 CFR Part 51, Subpart C)
  - e. Airport hazards
  - f. Historic preservation (Section 106)
  - g. Endangered species
  - h. Air quality
  - i. Environmental justice

(D) Agency Coordination

1. If required, coordinate directly with HUD for Part 50 reviews by responding to comments and requests for information.
2. If required, coordinate directly with the Responsible Entity for Part 58 reviews by responding to comments and requests for information.
3. Support NBHA or their designees on consultation with N.J. Historic Preservation Office (“NJHPO”), N.J. Department of Environmental Protection (“NJDEP”), or other agencies as required.

(E) Phase II and Mitigation Support, if required

1. If RECs or other concerns are identified, assist in evaluating the need for Phase II investigations, testing, or mitigation.
2. Prepare scopes of work for Phase II ESAs, if requested.
3. Provide support documentation of mitigation compliance for HUD clearance.

(F) NJDEP Coordination and Contamination Compliance, if required

1. Review applicable NJDEP databases, including Known Contaminated Sites, Industrial Site Recovery Act (“ISRA”) applicability, and groundwater classification.

2. Identify potential NJDEP regulatory requirements, including remedial investigation, remedial action, or deed notice considerations.
  3. Coordinate as needed with NJDEP or Licensed Site Remediation Professionals (“LSRPs”).
  4. Assist the Authority in documenting NJDEP status, regulatory closure, or mitigation measures required for HUD approval.
- (G) Provide any other Environmental Consulting services required by the development funding mechanism(s) selected by the NBHA, which may include, but not be limited to Section 8 PBVs, RAD, Section 18 demolition / disposition, LIHTCs, and other public or private sources.
- (H) Provide any other Environmental Consulting services necessary for the completion of the Fourward Hill development, as requested by the NBHA Board of Commissioners and/or Executive Director.

#### 4. QUALIFICATIONS

Respondents shall meet the following minimum requirements:

- A) Is authorized to do business in the State of New Jersey.
- B) Is capable of providing the requested scope of services in accordance with the requirements set forth herein.
- C) Is able to truthfully and accurately provide all information required on the Qualifications Statement.
- D) Is approvable by HUD.

Failure to meet any of the foregoing qualifications is considered a material defect and shall result in the disqualification of the Respondent.

#### 5. PROPOSAL REQUIREMENTS

- A. Proposals shall be submitted on the company letterhead, and signed by the owner or an executive officer of the firm.
- B. **Narrative** – Provide a narrative description of the respondent’s business and proposed services, which shall include the following elements:
  1. **Executive Summary** – Provide a brief non-technical overview of the Respondent’s business including the range of services offered. Respondents should demonstrate

how and why their services meet the Housing Authority’s needs and qualification requirements.

2. **Company Profile** – Provide a history of the business and resumes of key staff to be involved in all aspects of the Environmental Consulting services. This shall include both the company’s history providing Environmental Consulting services generally, as well as its experience providing such services to HUD-subsidized properties in the State of New Jersey.
  3. **Proposed Services** – Describe in detail each aspect of the proposed services.
  4. **Proposed Fees** – Provide a schedule of hourly rates for all categories of staff who will be assigned to perform services if a contract is awarded; and other charges, if any, must be specified. The Housing Authority shall not reimburse or otherwise pay for any travel-related expenses. The Housing Authority shall reimburse for the cost (including 10% markup) of materials used in providing the requested services. Invoices shall be accompanied by reliable proof of the actual cost of materials.
- C. **Required Documentation** – Respondents shall submit a printed copy and a flash drive containing a PDF copy of their proposal, including the enclosed checklist and all documentation identified therein. Failure to provide any of the required documentation at the time of submission may be considered a fatal defect warranting rejection of the proposal.
- D. **Insurance** – Respondents shall possess the insurance coverages specified on the Qualifications Statement. The premium cost of all insurance purchased by the Respondent for protection against risks assumed by virtue of the contract shall be borne by the Respondent and is not reimbursable by the Housing Authority. The Housing Authority specifically reserves the right to require the Respondent to provide certified copies of any and all insurance policies.

## 6. SUBMISSION REQUIREMENTS

Interested firms are invited and strongly encouraged to attend a pre-response walkthrough of the sites on **February 17, 2026** at **11:00 a.m.** The starting location is in front of the Housing Authority’s offices, located at 7 Van Dyke Avenue, New Brunswick, New Jersey 08901.

- B. The Housing Authority reserves the right to waive any informality and to reject any and all proposals. No Proposal may be withdrawn for sixty (60) days after the due date. Proposals may be withdrawn prior to the due date either in person or by mail.
- C. The contract shall be awarded to the respondent who submits the proposal most advantageous to the Housing Authority, cost and other factors considered.
- D. The successful respondent shall be required to execute the Housing Authority’s contract(s) within seven (7) days of receiving the notice of award.

## **AMERICANS WITH DISABILITIES ACT OF 1990**

### **Equal Opportunity for Individuals with Disability**

The contractor and the Housing Authority of the City of New Brunswick (hereafter “owner”) do hereby agree that the provisions of Title II of the Americans With Disabilities Act of 1990 (the "Act") (42 *U.S.C.* 12101 et seq.), which prohibits discrimination on the basis of disability by public entities in all services, programs, and activities provided or made available by public entities, and the rules and regulations promulgated pursuant there unto, are made a part of this contract. In providing any aid, benefit, or service on behalf of the owner pursuant to this contract, the contractor agrees that the performance shall be in strict compliance with the Act. In the event that the contractor, its agents, servants, employees, or subcontractors violate or are alleged to have violated the Act during the performance of this contract, the contractor shall defend the owner in any action or administrative proceeding commenced pursuant to this Act. The contractor shall indemnify, protect, and save harmless the owner, its agents, servants, and employees from and against any and all suits, claims, losses, demands, or damages, of whatever kind or nature arising out of or claimed to arise out of the alleged violation. The contractor shall, at its own expense, appear, defend, and pay any and all charges for legal services and any and all costs and other expenses arising from such action or administrative proceeding or incurred in connection therewith. In any and all complaints brought pursuant to the owner’s grievance procedure, the contractor agrees to abide by any decision of the owner which is rendered pursuant to said grievance procedure. If any action or administrative proceeding results in an award of damages against the owner, or if the owner incurs any expense to cure a violation of the ADA which has been brought pursuant to its grievance procedure, the contractor shall satisfy and discharge the same at its own expense.

The owner shall, as soon as practicable after a claim has been made against it, give written notice thereof to the contractor along with full and complete particulars of the claim. If any action or administrative proceeding is brought against the owner or any of its agents, servants, and employees, the *owner shall* expeditiously forward or have forwarded to the contractor every demand, complaint, notice, summons, pleading, or other process received by the owner or its representatives.

It is expressly agreed and understood that any approval by the owner of the services provided by the contractor pursuant to this contract will not relieve the contractor of the obligation to comply with the Act and to defend, indemnify, protect, and save harmless the owner pursuant to this paragraph.

It is further agreed and understood that the owner assumes no obligation to indemnify or save harmless the contractor, its agents, servants, employees and subcontractors for any claim which may arise out of their performance of this Agreement. Furthermore, the contractor expressly understands and agrees that the provisions of this indemnification clause shall in no way limit the contractor’s obligations assumed in this Agreement, nor shall they be construed to relieve the contractor from any liability, nor preclude the owner from taking any other actions available to it under any other provisions of the Agreement or otherwise at law.

**MANDATORY AFFIRMATIVE ACTION LANGUAGE**

**Goods, Professional Service and General Service Contracts**

During the performance of this contract, the contractor agrees as follows:

The contractor or subcontractor, where applicable, will not discriminate against any employee or applicant for employment because of age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation or sex. Except with respect to affectional or sexual orientation, the contractor will take affirmative action to ensure that such applicants are recruited and employed, and that employees are treated during employment, without regard to their age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation or sex. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided by the public agency compliance officer setting for the provisions of this nondiscrimination clause.

The contractor or subcontractor, where applicable will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation or sex.

The contractor or subcontractor, where applicable, will send to each labor union or representative or workers with which it has a collective bargaining agreement or other contract or understanding, a notice, to be provided by the agency contracting officer, advising the labor union or workers' representative of the contractor's commitments under this act and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

The contractor or subcontractor, where applicable, agrees to comply with any regulations promulgated by the Treasurer pursuant to N.J.S.A. 10:5-31 et seq., as amended and supplemented from time to time and the Americans with Disabilities Act.

The contractor or subcontractor agrees to make good faith efforts to employ minority and women workers consistent with the applicable county employment goals established in accordance with N.J.A.C. 17:27-5.2 or a binding determination of the applicable county employment goals determined by the Division, pursuant to N.J.A.C. 17:27-5.2.

**1. Preparation of Offers**

(a) Offerors are expected to examine the statement of work, the proposed contract terms and conditions, and all instructions. Failure to do so will be at the offeror's risk.

(b) Each offeror shall furnish the information required by the solicitation. The offeror shall sign the offer and print or type its name on the cover sheet and each continuation sheet on which it makes an entry. Erasures or other changes must be initialed by the person signing the offer. Offers signed by an agent shall be accompanied by evidence of that agent's authority, unless that evidence has been previously furnished to the HA.

(c) Offers for services other than those specified will not be considered.

**2. Submission of Offers**

(a) Offers and modifications thereof shall be submitted in sealed envelopes or packages (1) addressed to the office specified in the solicitation, and (2) showing the time specified for receipt, the solicitation number, and the name and address of the offeror.

(b) Telegraphic offers will not be considered unless authorized by the solicitation; however, offers may be modified by written or telegraphic notice.

(c) Facsimile offers, modifications or withdrawals will not be considered unless authorized by the solicitation.

**3. Amendments to Solicitations**

<sup>1</sup> Engaged in prohibited activities in Russia or Belarus" means (1) companies in which the Government of Russia or Belarus has any direct equity share; (2) having any business operations commencing after the effective date of this act that involve contracts with or the provision of goods or services to the Government of Russia or Belarus; (3) being headquartered in Russia or having its principal place of business in Russia or Belarus, or (4) supporting, assisting or facilitating the Government of Russia or Belarus in their campaigns to invade the sovereign country of Ukraine, either through in-kind support or for profit.

## FORM OF CONTRACT

**THIS AGREEMENT** made on [redacted], by and between the **HOUSING AUTHORITY OF THE CITY OF NEW BRUNSWICK**, 7 Van Dyke Avenue, New Brunswick, New Jersey 08901 (hereinafter called the “HOUSING AUTHORITY”) and [name], [address] (hereinafter called the “CONSULTANT”).

**WITNESSETH**, that the Housing Authority and the Consultant, for the consideration stated herein, agree as follows:

**ARTICLE 1: Scope of Services.** The Consultant shall provide the full range of services identified in the Housing Authority’s Request for Proposals and the Consultant’s Proposal. The services shall be provided in a competent and professional manner, in accordance with prevailing professional standards and applicable Federal, State, and Local statutes, rules, regulations, ordinances, orders, and codes. The Housing Authority shall be entitled to a satisfactory performance of all Services and to full and prompt cooperation by the Consultant in all aspects of the Services. The Consultant shall be responsible for all damages arising out of or resulting from the Consultant’s performance under this Contract.

**ARTICLE 2: Qualifications.** The Consultant represents that its personnel have the proper skill, training, background, knowledge, experience, rights, authorizations, integrity, character and licenses as necessary to perform the services described herein in a competent and professional manner.

**ARTICLE 3: Agreement Term.** This Agreement shall be in effect for the one-year period commencing [redacted] and ending [redacted]. The Housing Authority shall have the option to extend this Agreement for up to four subsequent one-year terms. The terms and conditions of this Agreement shall govern and be in effect during any such duly authorized extension period(s).

**ARTICLE 4: Compensation.** The Consultant shall be compensated for the services provided according to the terms of this Agreement at the hourly rate(s) specified in the Consultant’s Proposal. The total amount paid under this Agreement shall not exceed the sum of [redacted]. In the event that this not-to-exceed amount is reached and the Housing Authority does not authorize further expenditures, the Consultant shall have no further obligation to perform services under this Agreement. The Consultant shall submit detailed monthly invoices to the Housing Authority which identify all services performed and contain a full cost breakdown for all such services. The invoices shall be reviewed for payment approval by the Housing Authority’s Executive Director.

**ARTICLE 5: Insurance.** The Consultant shall obtain and maintain adequate insurance coverage, as identified in the Housing Authority’s Request for Proposals, throughout the term of this Agreement. The Housing Authority shall be notified in writing at least thirty (30) days prior to any change in or cancellation of insurance coverage.

**ARTICLE 6: Indemnification.** The Consultant shall indemnify and hold harmless the Housing Authority and its Board, Commissioners, officers, directors, and employees from and against any and all claims, suits, actions, damages, losses and expenses, including but not limited to reasonable attorneys’ fees, arising out of or resulting from the Consultant’s performance under this Contract.

**ARTICLE 7: Subcontracting.** The Consultant shall be solely responsible for the performance of this Agreement. The use of a Subcontractor, except as approved in writing by the Housing Authority’s Chairperson, shall be prohibited. Approval of a subcontractor shall be granted in the Housing Authority’s sole discretion. Substitution of a subcontractor without the Housing Authority’s written approval is prohibited. Any use of a Subcontractor in violation of this provision shall be deemed a material breach of this Agreement.

**ARTICLE 8: Independent Contractor Relationship.** The Consultant is, and shall be, in the performance of its obligations under this Agreement, an independent contractor, and not an employee, agent or servant of the Housing Authority. All persons engaged in any of the services performed pursuant to this Agreement shall at all times, and in all places, be subject to the Consultant’s sole direction, supervision and control.

**ARTICLE 9: Termination for Convenience.** The Housing Authority may terminate this Agreement, in whole or in part, by delivering to the Consultant written notice four (4) weeks prior to any effective termination date. The Notice of Termination shall specify: 1) that the termination is for the convenience of the Housing Authority; 2) the extent of the termination; and 3) the effective date of the termination. In the event of a termination for convenience hereunder, the Housing Authority shall pay the Consultant for services rendered through the date of termination.

**ARTICLE 10: Termination by Default.** This Contract may be terminated if there has been a material default in the performance or observance of any term or condition herein by the Consultant. The failure to perform any of the following shall constitute an event of default: 1) failure to satisfactorily and timely perform any or all of the services specified herein; 2) discontinuation of services without authorization or justification; 3) failure to maintain adequate insurance coverage; 4) failure to comply with applicable legal requirements; and 5) suspension from participation in any federal or state government programs. The Housing Authority may, in its discretion, elect not to declare a default or to terminate the contract, but such election shall not constitute a waiver by the Housing Authority of its right to pursue any or all available legal remedies, nor shall Consultant be relieved of any of its responsibilities, duties or obligations under this Contract.

**ARTICLE 11: Prevailing Law.** This Agreement shall be governed by and construed in accordance with the laws of the State of New Jersey without reference to choice of law principles. Any and all disputes arising out of or related to this Agreement, or the services provided hereunder must be brought in the Superior Court of New Jersey, Middlesex County.

**ARTICLE 12: Non-Debarment.** By execution of this Agreement, the Consultant certifies that it is not currently debarred by the Federal government, including the U.S. Department of Housing and Urban Development or any other Federal agency, the State of New Jersey, or any State agency.

**ARTICLE 13: Confidentiality.** All Services performed and provided under this Agreement, and other materials, data, transactions of all forms, financial information, documentation, inventions, designs and methods obtained from the Housing Authority in connection with the Services performed under this Agreement, made or developed by the Consultant in the course of the performance of such Services, or the results of such Services, or for which the Housing Authority holds the proprietary rights, constitutes confidential information (“Confidential Information”) and may not, without the prior written consent of the Housing

Authority, be used by the Consultant for any purpose other than for the benefit of the Housing Authority, unless required by law.

**ARTICLE 14: Non-Discrimination.** The Consultant agrees not to discriminate against any employee or applicant for employment because of race, religion, color, sex, sexual orientation, handicap, marital status, age, national origin or status as a veteran of the United States military, and to take affirmative action to ensure that they are afforded equal employment opportunities without discrimination. Such action shall be taken with reference to, but not limited to, recruitment, employment, termination, rates of pay or other forms of compensation, and selection for training or retraining, including apprenticeship and on the job training.

**ARTICLE 15: Conflicts of Interest.** The Consultant represents that it does not presently have any interest and will not acquire any interest, direct or indirect, which would conflict in any manner or degree with the performance of its obligations under this Agreement.

**ARTICLE 16: Assignment.** The Consultant shall not assign, transfer, convey, or otherwise dispose of this Agreement, including its rights, title, or interest in or to the same of any part thereof without the prior written consent of the Housing Authority. Any purported assignment without the prior written consent of the Housing Authority shall be void and unenforceable.

**ARTICLE 17: Severability.** If this Agreement contains any provision found to be unlawful by a court of competent jurisdiction, the same shall be deemed to be of no effect and shall be deemed stricken from this Agreement without affecting the binding force of this Agreement as it shall remain after omitting such provision.

**ARTICLE 18: Counterparts.** This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which shall together constitute one and the same instrument.

**ARTICLE 19: Integration.** This Agreement and the Housing Authority's Request for Proposals shall constitute the entire agreement and understanding of the parties hereto with respect to the subject matter contained herein, and supersedes all prior agreements, promises, covenants, arrangements, communications, representations or warranties, whether oral or written, by any officer, employee or representative of any party hereto.

**ARTICLE 20: Subsequent Modification.** This Agreement may not be changed or modified except by written agreement specifically referencing this Agreement and executed by each of the parties hereto.

**ARTICLE 21: Effect of Headings and Titles.** The headings and titles used in this Agreement are solely for convenience of reference and shall not affect its interpretation or construction.

**ARTICLE 22: No Interpretation Against Draftsman.** This Agreement shall be construed without regard to any presumption or other rule requiring construction against the party causing this Agreement to be drafted.
